The purpose of this study is to gain understanding about nurse practitioners'(NPs) prescriptive decision making for geriatric patients with attention to pharmaceutical marketing influences. Findings revealed overwhelming consistency among the NP participants that their nursing background instilled a holistic approach that encompassed both non-drug and therapeutic drug options, skepticism about drug marketing and offered a positive difference by tailoring to their patients' biophysical, psychological, and economic needs with an involvement in the interplay of geriatric care issues not typically addressed by physicians.
