- 98** **Improving person-centered mobility care in nursing homes: A feasibility study**

Individualized mobility care requires staff to understand residents' mobility capacity and to safely meet residents' mobility needs through use of mobility enhancing strategies that encourage and allow residents to move themselves where possible. The purpose of the current study was to evaluate the feasibility of an intervention to improve person-centred mobility care during resident transfers.

- 106** **Caring for people with dementia in residential aged care: Successes with a composite person-centered care model featuring Montessori-based activities**

Gail Roberts, Catherine Morley, Wendy Walters, Sue Malta, and Colleen Doyle

Significant behavior changes were evident among residents of the dementia

care unit after the model was introduced, as were reductions in antipsychotic and sedative medication. Staff reported increased knowledge about meeting the needs of people with dementia, and experienced organizational culture change that supported the ABLE model of care. Families were very satisfied with the changes.

- 111** **The effect of a "surveillance nurse" telephone support intervention in a home care program**

Results indicated a beneficial effect of the surveillance nurse intervention on reducing rate of service utilization by increasing the duration of the home care episode.

- 120** **Nursing home practices following resident death: The experience of Certified Nursing Assistants**

Study findings suggest that more mindful approaches to the transitions related to resident deaths would be valued by CNAs and could improve their work experience.

- 126** **Relationship between missed care and urinary tract infections in nursing homes**

September T. Nelson and Linda Flynn

Nearly one half of nurses reported missing at least one necessary care activity during their last shift. Regression analysis indicated that failure to administer medications on time and

failure to provide adequate patient surveillance explained 40% of the variance in the percent of residents with urinary tract infections in this sample.

131 Older adults' favorite activities are resoundingly active: Findings from the NHATS study

For all ages, four of the top five most common favorite activities are active: walking/jogging (14%), outdoor maintenance (13%), playing sports (8.9%), and other physical activity (8.7%). These findings sustain in 65-70 and 70-75 year olds. Even in 80-84 year olds, 3 of the top five activities are active.

136 Chronic kidney disease and recurrent falls in nursing home residents: A retrospective cohort study

Rasheeda K. Hall, Lawrence R. Landerman, Ann M. O'Hare, Ruth A. Anderson, and Cathleen S. Colón-Emeric

Chronic Kidney Disease was not an important predictor of falls in this cohort of nursing home residents with prior falls. Instead, traditional fall risk factors were much more strongly associated with recurrent falls.
