### Forever Chemicals (PFAS): An Overview for Maternity and Pediatric Health Care Professionals

Per- and polyfluoroalkyl substances (PFAS) constitute a large class of chemicals with widespread exposure in the United States. Concerns about the health impacts from PFAS exposures continue to grow as science has linked this chemical family with a wide range of health effects. An overview of this issue and related health concerns is presented in the context of implications for maternity and pediatric patients.

# Labor and Delivery Nurses' Perceptions of Their Colleagues' Attitudes and Behaviors Toward Pregnant Patients with Substance Use

In this study, 154 nurses from 14 Colorado hospitals that represented 45% of the state's 2022 births participated in a survey about attitudes and behaviors towards patients with substance use disorders and mental health concerns. Half of the nurses reported their colleagues have negative attitudes and nearly one-third reported negative behaviors toward patients who disclose substance use. Qualitative data revealed positive behaviors such as supportive clinical care and resource provision for patients disclosing substance use. Mistrust, negative attitudes, lack of compassion towards patients, and instances of substandard clinical care were offered as negative behaviors observed.

#### Bedsharing Perspectives among Latino Caregivers

Bedsharing is an unsafe practice that increases risk of adverse newborn and infant outcomes. In this study 45 caregivers explain factors in their decision-making processes about bedsharing and information that helped them avoid it. Pediatrician advice against bedsharing was a major factor. Findings can help members of the maternity and pediatric health care team advise and inform new parents about bedsharing.

### 157 Relationship Between Anxiety and the Birth Experience of Hispanic Adolescents

In this study, effects of anxiety on the birth experience of 127 Hispanic adolescents 13 to 19 years of age without comorbid major depression were explored using a cross-sectional secondary analysis design including subjective rating of the birth experience and anxiety level, and an objective anxiety score using the Edinburg Postnatal Depression Inventory-A (EPDS-A). Self-reported anxiety and type of birth were found to affect their birth experience. Negative birth experiences and potential mental health consequences support postpartum follow-up for at-risk adolescents.

#### 62 Keeping Mothers Together with Their Babies Requiring Neonatal Intensive Care during the Birth Hospitalization: An Innovative Model of Care

Keeping mothers and their newborns together during the birth hospitalization is generally agreed to promote breastfeeding and maternal-infant bonding. When the newborn needs more than level I care, most mother-baby couplets are separated, with the baby cared for in a special care nursery or neonatal intensive care unit while the mother is a patient on the postpartum unit. In this innovative care model, a new unit configuration and leadership initiatives supported a change in practice where newborns requiring level I or level II care remain in the postpartum room with their mother, and both receive the appropriate care based on their needs. ## Education and Evaluation of Electronic Fetal Monitor Interpretation: A Scoping Review

This scoping review covers an assessment of the state of electronic fetal monitoring education and competence evaluation. Although electronic fetal monitoring is commonly used, studies about education and competence validation for clinicians who are expected to interpret fetal monitoring data are limited. There is a need to improve education and evaluation of fetal hear rate tracing interpretation skills including integrating evidenced-based educational design practices and rigorous learner evaluation to ensure safe and accurate interpretations.
