

Ella's mother writes: "Ella is two years old and has an extremely rare brain disorder called Congenital Bilateral Perisylvian Syndrome..Ella's brain never fully developed nor did the outer covering of her brain or the motor cortex. Because the motor cortex never fully developed. Ella is also hypoglycemic; she has an atrial septal defect (ASD) (hole in her heart) that will be fixed soon. In addition to pulmonary valve stenosis (another heart defect), Ella also has airway disease. She has been through a lot, but she proves how strong she is everyday. She is absolutely amazing, and we cherish every moment we get to spend with her!"
